KITAS TRANSFER POSITION

For foreigners who want to change the position or status of work to investor in the same company have to proceed this KITAS.

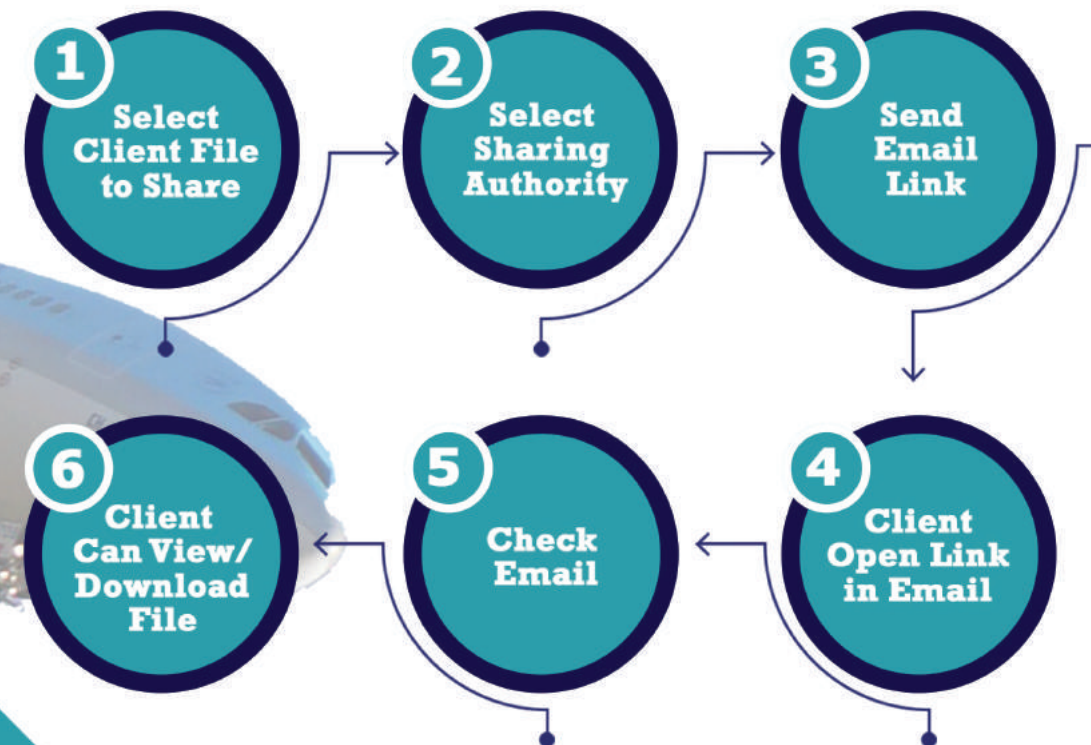
KITAP

DEED AND DECREE OF JUSTICE

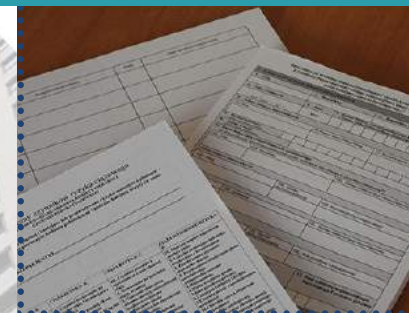

- Category B (alcohol 5% - 20%).
- Category C (alcohol > 20%).

NPPBKC is one of requirements to make SIUPMB License complete.
